Federal advocate: Simon & Company

- Simon and Company is a Washington, D.C. based firm that provides federal affairs and legislative assistance to mainly public agency clients.
- Simon & Company has represented Access for more than a decade. Simon & Company has developed an expertise and understanding of the issues facing Access Services and paratransit agencies in general.
- Ms. Jen Covino is the current President and our primary contact.







Key Issues

- Monitor and track all legislation (e.g. Reauthorization) and regulations that may affect Access' funding, administration, and/or operations.
- Proactively seek additional funding and consistency in regulations.
- Oppose legislation or regulatory proposals that would significantly expand the requirements of ADA transportation without providing necessary funding.
- Meet with elected officials and staff in Washington, DC to discuss Access initiatives, and work constructively with FTA officials.



Advocacy Efforts



- In 2007, Simon and Company was instrumental in helping Access receive its first federal earmark. The \$735,000 grant was used to help integrate Access into the regional Transit Access Pass (TAP) program.
- Simon helped Access work with the U.S. General Services Administration (GSA) to allow Access to purchase Smartdrive cameras off the federal bid list, which saved the agency a significant amount of money and resources.
- Simon helped Access work with its legislative delegation to insert language in the 2015 FAST Act that allowed Access to keep its coordinated fare system.
- Simon and Company continues to assist staff with funding opportunities as they become available through various federal agencies.

- Gonsalves & Son was founded by former Assemblyman Joe A. Gonsalves in 1975. The firm is led by Anthony Gonsalves and includes his two sons Jason Gonsalves and Paul Gonsalves.
- Gonsalves & Son has over 50 years of legislative experience and represents more cities than any other California lobbying firm.
- Access has worked with Gonsalves for over 10 years.





Key Issues

- elected
- Represent Access in Sacramento with elected representatives, key staff members, state agencies.
- Execute Access' advocacy efforts, including communication with legislative and other governmental officials for the purpose of influencing legislation or administrative action.
- Obtain support from elected officials for Access grant applications.
- Attend and provide testimony on behalf of Access in legislative committee hearings.
- Monitor and track all legislation and regulations that may affect Access' funding and/or operations.







- In 2019, Gonsalves worked with staff to draft and distribute a letter outlining the effects of Assembly Bill 5 on its taxi subcontractors and asking that the taxi industry be exempted from the legislation.
- In 2018, Gonsalves coordinated a meeting with Department of Health Care Services to seek clarification on regulations governing the reimbursement of Medi-Cal transportation. The meeting helped Access staff develop a strategy to pursue reimbursement, which could generate significant monies for the agency.
- Gonsalves has passed several bills related to Access, including legislation clarifying that Access is a public entity.


Local Advocate: David Gershwin Consulting

- David Gershwin has two decades of experience working in L.A. city politics and local government.
- He served as Chief of Staff to current Mayor Eric Garcetti when the Mayor served as the President of the Los Angeles City Council.
- Before working with Mayor Garcetti, Mr. Gershwin served as Communications Director for then Council President Alex Padilla.









- Ensure adequate regional funding for paratransit service
- Inform elected officials and stakeholders about the provision of ADA paratransit in L.A. County
- Address constituents concerns as needed
- Inform stakeholders about Access projects and initiatives, including autonomous vehicles
- Assist with Access' internal and external communications, including media relations










- There are numerous occasions where Mr. Gershwin has helped Access staff work with local political offices and other entities on issues related to Access' operations.
- Mr. Gershwin has helped raise Access' profile and established a positive dialogue with Mayor Garcetti's office and the offices of Los Angeles Councilmembers and other elected officials.
- He is on call in the event of emergencies and has assisted staff with media relations.











- New state law modifies who should be considered an employee versus an independent contractor
- Could require many taxi drivers to be classified as employees
- This would significantly impact Access as roughly 50% of Agency trips are performed by taxis
 - Potentially reduce the availability of taxis
 - Significantly increase the cost of delivering service for the region






AB 5 Status



- Taxi operators are seeking an exemption from the law
- Access is working in coordination with Metro's government affairs staff to support this effort and has submitted a letter of support
- Access has commissioned a study to determine the cost impacts on its operations from AB 5
- There are no immediate impacts to Access' operations or budget




