Last Friday at 4:30 am, Access activated its Emergency Operations Center (EOC) in response to the Saddle Ridge Fire in Sylmar, which led to the closure of a number of major freeways and the evacuation of residents from the affected areas.

During the day, Access staff monitored the fire and its effect on our contractors and customers. Customers in the affected areas were sent a message via our Everbridge emergency notification system. Transfer trips between the Los Angeles basin and North County were canceled. In addition, Access customers canceled approximately 800 trips. Thankfully, the fire was contained by the following day.

I would like to thank Access staff and our contractors for doing their best to ensure the safety of our customers during this natural disaster.

LIT was founded in 2016 by Flora Castillo, Founder and President of Pivot Strategies, LLC, and Terry Solis, Chairman and Secretary of the Board of Directors at The Solis Group. These women had an idea to create, promote, and develop Latinos in Transit in both the private and public sectors through a national network of transportation professionals. Los Angeles Cyber Lab Security Summit

I recently attended the Los Angeles Cyber Lab Security Summit at the Bonaventure Hotel in Downtown Los Angeles. The LA Cyber Lab launched in 2017 and focuses on outreach, education, and information sharing between the public and private sectors about cybersecurity matters.

The theme for the summit was Connecting the Community through cybersecurity and bringing awareness to the cyber ecosystem. The summit started with a welcoming address from L.A. Mayor Eric Garcetti, in which he discussed the city's new Threat Intelligence Sharing Platform or TISP. TISP was developed in partnership with IBM to help businesses defend against cybercrime. TISP is aimed at smaller, mid-sized businesses, offering threat tracking capabilities that otherwise wouldn't be accessible to these companies. It also comes with a mobile app, available through Apple and Google Play, designed to allow any user to report and share information about potentially malicious emails.

Cybersecurity awareness is more critical than ever as reports indicate that cybercriminal activity is one of the biggest challenges that people will face in the next two decades. Cybercrime is projected to cause damages of over \$6 billion annually by 2021, up from \$3 billion in 2015.
