Executive Director's Report

The Access Services Board of Directors recently met on January 13th.

Board members and staff presented an overview of Access' new governance initiative, which is creating four standing subcommittees: Board Operations; Planning and Development; Performance Monitoring; and External/Stakeholder relations. These subcommittees, which will be chaired by Access' Board Officers, will meet every other month starting in March. The full Access Services Board will meet in April and every other month after that.

After this presentation, the Board heard a quarterly financial update where staff discussed how improvements in service quality have led to a significant increase in customer demand over FY 20 budgeted levels and a projected \$10-12 million deficit for FY 20. (Access' FY 20 operating budget is \$184 million.) The Board directed staff to work with Metro, the Agency's funding partner, on this issue.

The next Board of Directors meeting will be held on February 10th.

Meeting attendees had the opportunity to ask the panelists specific questions such as how to negotiate job offers, and what may be potential opportunities with the passage of Measure M. Those in attendance enjoyed a lively discussion, which included the sharing of experiences and stories.

Access attends FTA Triennial Review Workshop

The Federal Transit Administration (FTA) recently hosted a two-day Triennial Review (TR) workshop in downtown Los Angeles. Each year, the FTA conducts Triennial Review workshops across the country as a way to assist FTA grant recipients with federal rules, regulations, and compliance requirements.



During the workshop, recipients received assistance to help them prepare for the Triennial Review, including training materials, procedural guides, and other helpful documents. FTA Triennial Review contractors and regional office staff helped recipients, including new attendees, understand the importance of the program requirements.

At the end of the workshop, the regional office staff provided feedback. Grant recipients shared some helpful tips for navigating

through the review and the importance of planning ahead. I found the workshop to be helpful in understanding the FTA's requirements and also enjoyed engaging with other public transit agency staff who shared their Triennial Review experiences.
